

Models Terms and Conditions

- Tiff Models Ltd will secure as many suitable contracts for all registered models, but will not guarantee frequency or type of contract. It is the model's responsibility to provide Tiff Models Ltd updated and new photos and keep us informed of any new relevant experience in order to promote you for the clients. However every effort will be made to help models with updating photos.
- Upon booking, models will be notified with the full assignment details and rates of pay. This should be confirmed in writing by both Tiff Models Ltd & model assigned before the contract begins but can not be guaranteed in case of short notice of the booking. For the avoidance of doubt, the definition of 'acceptance of booking' includes verbal confirmation or any written document (including electronic), and shall be deemed as confirmed booking and to constitute acceptance of these Terms and Conditions.
- Tiff Models Ltd will endeavour to pay the model/s within one month of a satisfactory completed job or as soon as reasonably practical after the contract has ended. Tiff Models has the right, however, to extend the payment period if need be, and if circumstances beyond our control prevail. Method of payment to be discussed on individual basis.
- Tiff Models Ltd does not provide any holiday, sickness or maternity pay, nor pension rights or entitlement. Tiff Models Ltd will be responsible for all gross payments to the Model. Payment of all statutory contributions and Income Tax is the responsibility of the Model who is of self-employed status.
- Tiff Models Ltd reserves the right to withdraw payment if we feel a job has not been completed with satisfaction. This includes any breach of the 'Models Terms & Conditions' contract.
- Tiff Models Ltd accepts no liability for any items damaged or lost while engaged in a contract. This includes objects worked with, or used in any form during the agreed working hours. Furthermore, Tiff Models will accept no responsibility beyond the agreed working hours, nor pay overtime, unless otherwise specified in writing. Any overtime and/or assignment not been originally part of the booking, asked to perform by the client should be informed to Tiff Models Ltd before completion in order to guarantee payment for the overtime and/or extra assignment.
- Tiff Models Ltd has permission to forward any models photographs to potential clients, and to use these images to promote the model on our website, www.tiffmodels.co.uk and www.tiffmodels.com and any other agency relevant websites.
- If a booking is postponed or cancelled, Tiff Models Ltd will notify the selected model(s) immediately. Tiff Models Ltd has no financial liability to the model in a case of cancellation of a booking. However, Tiff Models Ltd will reimburse any reasonable travel expenses incurred by the model and every effort will be made to cover 50% of the agreed salary of the booking if cancellation occurs 48h prior to booking.

Our Models agree to:

- To conduct oneself in a professional and friendly manner at all times including not being late and knowing your booking and client details.
- On bookings/assignments, to look your best and well groomed with make-up and hair done and nails, skin and body looked after at all times.
- Carry out all assigned contracts to the best of your ability.
- Comply with all lawful instructions and requests made by either the client or by Tiff Models Ltd.

- Notify Tiff Models Ltd that you have received your Contract/Booking Details as soon as possible.
- Notify Tiff Models Ltd as soon as possible in the event that you are late to a booking. Tiff Models will deduct your pay by £10 for the first 30 minutes and a further £5 every fifteen minutes after.
- Give Tiff Models Ltd no less than 48 hours notice prior to the start of a booking if they are unable to attend the booking, or if the booking has started, immediate notice should they be unable to complete the booking due to sickness or other genuine reason. Tiff Models Ltd reserves the right not to pay the model on uncompleted bookings and/or assignments if model fails to provide a certified Doctor's Certificate as soon as possible or a concern arises of the reason/s for failing to complete the booking.
- If due to sickness a booking can not be attended, to provide a certified Doctor's Certificate as soon as possible. If doctor's certificate not provided, Tiff Models Ltd will consider carefully whether to continue finding work for the model in the future.
- To notify Tiff Models immediately of any changes to appearance, contact details, and health.
- Refrain from advertising themselves as 'freelance' models to any of Tiff Models Ltd's clients, not to agree contracts, or accept further work or bookings of any nature for the purpose of financial gain without liaising with Tiff Models Ltd first.
- Refrain from saying anything that could harm Tiff Models Ltd's reputation, or bring us into disrepute with any of our clients/potential clients.
- To inform Tiff Models latest the next day after completion of the booking of any details and concerns on the booking. Tiff Models endeavours to have satisfied and happy clients and models and therefore gets feedback from both.
- That Tiff Models Ltd will take commission from the clients charge, not the models pay unless the booking is within TV industry any kind.
- Be self-employed and responsible for their own income tax or national insurance on payments made to them.
- As an independent contractor it is understood by all parties that you are not an employee of either the client of Tiff Models Ltd.
